The Organization also supports the use of individual development accounts (IDAs) which is designed to purchase a home, capitalize a small business, or to assist in the purchase of a post-secondary education, by partnering with the United Way of Central Alabama to coordinate the state programs for IDAs.

Bank on Alabama program allows Alabama Asset Building Coalition to work together with financial partners and local communities to implement a statewide strategy to lower the number of the unbanked individuals throughout the State.

Through the financial education initiative program, the Organization is helping to conduct "train the trainer" programs, training nonprofit groups, financial institutions, churches, government agencies, college universities and other to teach financial education to the community.
