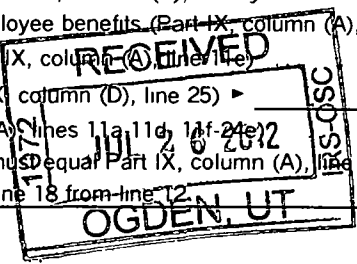

Human Impact Partners built the capacity of 17 organization/coalitions, including government agencies and community organizations, around the country to conduct Health Impact Assessments (HIA) by conducting 7 two day trainings and providing 17 organizations/coalitions with technical assistance as they conducted their own HIAs.

Human Impact Partners raised awareness about Health Impact Assessment and about the links between proposed policies, plans and projects and health outcomes by presenting at over 10 conferences, developing, disseminating, and/or publishing case studies and fact sheets.
