Purpose of this organization is "to increase youth involvement in Science, Technology, Engineering and Mathematics (STEM) education, sustaining their interest and building community pride and support for STEM education."

We are a year around organization. During the winter and early spring is "Build Season", where the students plan, design and build robots to compete in the First Robotic Challenge. In 2011, Innovators competed in five competitions, winning the Buckeye Regional (60 teams) and CORI (24 teams), placing second at IRI (70 teams), fifth at Worlds in St. Louis, MO. (360 teams) and Pittsburgh Regional (40 teams).

After the competitions, students demonstrate the robot to throughout southwest Ohio, for schools, community and science organizations.

We have completed over 70 robotic demonstrations over the last three years, where we encourage students to touch and drive the robot and answer their questions, to increase STEM education. One demonstration is ISPACE in Cincinnati, Ohio, on Space Day where over 2000 students visit to learn more about science.

During the summer, the organization assists with Science Camps at the Dayton, Ohio Kroc Center (an inter-city community center) and Wright-Patterson AFB Educational Outreach Program. During the fall, students mentor four First Lego League Teams in the Vandalia-Butler School System, Vandalia, Ohio, and a Northern Dayton, Ohio First Tech Challenge Team and assist with other teams in the area. In prior years, we also mentored teams in the Dayton inter-city and Dayton City Schools. In 2011, we partnered in hosting to host a Lego League Tournament in Springboro, Ohio.

Through the new Ohio Credit Flex program, the organization became an education partner working with the Vandalia-Butler System in developing a course work to receive high school credits. This allowed one student to graduate early and is now enrolled in college and we have two other students who are working to earning high school credits.

The organization has grown from one team and five students (pre non-profit) to over ten teams and 130 students competing on all levels in 2011.
