4. To fund research into Beefmaster genetics and cattle genetics in general in such areas such as feed efficiency, tenderness, longevity and other heritable traits in order to better serve the cattle industry and the general public with better products.

Form 990-EZ, Part III, Line 28 - First Accomplishment

The corporation awarded \$8,500 in college scholarship funds in July 2011 to young Beefmasters handlers during the annual Junior Beefmaster Breeders of America (JBBA) convention (Nine scholarships ranging from \$500 to \$2000). A \$1000 grant was given to JBBA for use in a public education segment of their annual national convention. A new round of 2012 scholarships is planned to be awarded in July 2012. The corporation continues to attract funds for use in a research project into Beefmaster genetics sometime in the 2012/2013 time frame depending on reaching a critical funding level of around \$100,000.

The corporation continues to raise awareness of its mission among Beefmaster Breeders and the general public. The corporation's website was completed and has assisted in raising awareness. Many small donations were received in 2011 indicating growing support of the corporation's mission.
