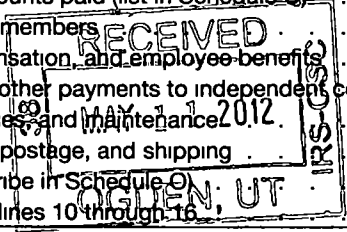



MEDF received \$52,974.62 in cash donations which includes payments of reimbursable utilities, travel expenses. MEDF also received more than 500 in donated hours of professional services ranging from free booking and accounting services, construction services, donated office supplies, free advertising, free fundraising services in terms distribution of flyers. These non-cash services totals \$40,431.76, which brings total revenues to \$93,406.
