One Town, Inc is extremely proud of its community garden. The first and only in Wrightwood, CA. The community garden is placed on land that was previously vacant, not build-able due to frequent flooding, and was becoming not only an eyesore, but potentially a place for juveniles to commit delinquent acts. The community garden contains 46 family/individual plots and 2 school gardens. The local schools have embraced the plots as a place of learning. There are approximately 100 students in this program. The plots help demonstrate the environmental and social benefits of gardening in many ways. School children are able to learn from their own actions in a scientific, social and environmental learning environment. The garden also provides a place of social community for the children as they learn from each other. In addition, the plots enable scientific learning. Children raise plants from seed to harvestable product. They learn various scientific concepts including but not limited to plant biology, water conservation, soil science, agricultural and environmental science. The students learn about their effects on the environment, not only in how they can grow plants that they can later eat, but how their actions effect the many creatures around them including birds, squirrels, worms, insects and many others. In addition, the garden provides a space for community for the many seniors in our area. The garden is open to the public and thereby increases the number of activities available to local seniors.

4b (Code: 517000) (Expenses \$ 18,600 including grants of \$ 0) (Revenue \$ 0)

One Town, Inc has built the infrastructure to offer free wireless internet to Wrightwood residents. The program is currently in a testing phase. To date around 11 families in the Wrightwood area are using and testing the internet service. In the summer of 2011, Verizon, the local DSL provider announced that they would no longer offer DSL ports in Wrightwood. If a resident were to move or temporarily lose their service Verizon would not renew their service. In addition, all new residents to the area would not be able to get DSL, even if the previous owner or tenant had service at the same location. This created an extreme and insurmountable hardship on local residents, business owners and the local government. One Town offered to lessen the burden upon the local government to solve the problem by setting up a free wireless system for use by local residents. This service not only eases the burden on the County government in rectifying the situation with Verizon.

The Skyline Amphitheater was built in order to promote the arts in the town of Wrightwood. The amphitheater will be used by local groups, including the tax-exempt nonprofit, the Wrightwood Community Players, for outdoor summer performances. One Town, Inc offers the use of the stage to nonprofit groups free of charge, and to other local community groups offering free performances.
