

A total of 14 short term mission teams served with Groundwork Guatemala in 2011, with a total of 126 people on those teams.
These teams prepared and presented Faith Lessons in each of our ministry locations (weekly attendance of approximately 600), in line with our mission statement "Our mission is to take the Living Word, Jesus Christ,
to the lost of Guatemala and equip the found for a life of service to their Savior." Medical clinics were conducted,
as well as visiting the lonely, struggling and infirm among the poor. Through their experiences in Guatemala,
many lives of both Guatemalans and those on the teams are changed into lives of service and discipleship.
Additional program service revenue not spent directly on the team goes into a transportation fund for future vehicle repairs,
maintenance, and purchases.

Believing that education opens doors of opportunity for children and their families, in 2011, 96 students received educational
scholarships, made possible through the donations of sponsors. Each scholarship can cover registration and other fees,
monthly tuition, uniforms, shoes and school supplies.

Each week, the ministry team goes to various sites in Guatemala City, Amatitlán, and Buena Vista to conduct house
visits and Faith Lessons. We are a very relational ministry, believing that as relationships are built and strengthened, many of
the emotional, spiritual and physical needs of the people we serve can be discovered and met. Our weekly attendance at these
activities in 2011 was estimated at 600. Approximately 320 miles are driven to the various ministry
sites. Expenses incurred as a result of conducting these activities are operation and maintenance of vehicles, craft and
educational supplies, medications, and the economic aid given to the Guatemalans on staff who conduct these activities.
