Pets for Vets, Inc. established chapters in 6 states in order to offer the program to more veterans. Chapter volunteers needed supplies and equipment in order to implement the program. The executive director developed the training program and traveled to chapter sites to train chapter personnel. The executive director and board members provided ongoing mentoring.

4b (Code: _____) (Expenses \$ 25,002 including grants of \$ 21,714) (Revenue \$ _____)

In addition to adoption, training and veterinarian fees, the dogs are up to date on shots, spayed/neutered, micro-chipped and healthy. Pets for Vets placed 10 dogs in 2011. During this process, Pets for Vets professional trainers visited shelters to find just the right match for a specific veteran, considered the dog's temperament, conducted a thorough assessment of the dog and observed the dog's socialization skills. When a dog has been selected, one of our trainers takes the dog home for rehabilitation. Dogs are trained to CGC standards and "good house manners" and are socialized. Pets for Vets uses only positive reinforcement, non-force based, training techniques; this training is important for every animal but especially for animals whose backgrounds are unknown. Our training program is very personal and hands-on because we want our dogs to fit seamlessly into the veteran's daily life. The trainer stays in touch with the veteran during the process and after the match is made. Each veteran-pet match is given a Welcome Package to start their new life together.
