Residents of the island collect rainwater in cisterns for individual use but they can be affected direly by periods of drought. The local government will maintain the completed project and will provide a tank truck to distribute water during the drought season. Grenadines Partnership Fund continues to explore other funding opportunities for this project

Construction of the museum (began in 2010) to house and preserve the cultural history of the tiny island of Bequia was completed in 2011. The island is known for its shipbuilding, sailing and whaling roots and the museum will provide the means to preserve Bequia's heritage

4c (Code: ) (Expenses \$ 56,913 including grants of \$ 52,796 ) (Revenue \$ )  
Project involved refurbishing of an aged building to use for training young girls in domestic skills and to develop small marine motor skill sets in young men. The building will also be used for other training and adult education classes. Project will provide new economic opportunities on the island of Bequia. The project was completed on time and within budget in 2011.
