IN 2011, BEPA GAVE AN ENTIRE COMPUTER LAB TO THE ACADEMY - THE COMPUTERS AND MONITORS WERE DONATED IN WASHINGTON, CLEANED AND UPGRADED, AND SHIPPED TO JAMAICA AT OUR EXPENSE. WE ALSO WIRED AND INSTALLED THE COMPUTERS, AND VOLUNTEERS WENT TO JAMAICA AND TO THE SCHOOL, AND HELPED SORT OUT THE PROGRAMMING SO THAT THEY WERE NETWORKED, UP AND RUNNING IN THE CLASSROOM. WE ALSO PURCHASED AND DELIVERED FRESH FRUITS AND VEGETABLES FOR THE ACADEMY'S CAFETERIA SO THAT IT WOULD BE ABLE TO PROVIDE FOOD FOR STUDENTS SENT TO SCHOOL WITH NO LUNCH MONEY.

THE BLUEFIELDS BASIC SCHOOL (NURSERY SCHOOL)

THE BLUEFIELDS BASIC SCHOOL PROVIDES EARLY CHILDHOOD EDUCATION TO CHILDREN AGED THREE TO SIX, AND CURRENTLY CATERES TO ROUGHLY 60 CHILDREN. WE SUPPLEMENT TEACHERS' SALARIES AND HELP WITH CONTINUING PROFESSIONAL EDUCATION, AND ACT AS TREASURER OF THE SCHOOL, OVERSEEING ALL ASPECTS OF HOW MONEY IS SPENT. THIS INCLUDES BUYING FRESH FRUITS AND VEGETABLES FOR SCHOOL LUNCHES AND PAYING A COOK TO GIVE THE CHILDREN A HOT LUNCH. WE TAKE A PARTICULAR INTEREST IN THE CHILDREN'S DIET AS OBESITY IS A GROWING PROBLEM IN JAMAICA THANKS TO AN ABUNDANCE OF PACKAGED FOOD.

POOR RELIEF, SCHOLARSHIPS AND MEDICAL ASSISTANCE PAID TO INDIVIDUALS. EACH MONTH, APPROXIMATELY \$50 IS GIVEN TO RETIRED SENIOR CITIZENS WHO ARE IN POOR HEALTH AND UNABLE TO PAY FOR ADEQUATE TREATMENT. CURRENTLY, FIVE PEOPLE (WITH AN AVERAGE AGE OF 73, AND THE OLDEST BEING 89) RECEIVE MONTHLY CHECKS, WHICH HELP WITH MEDICINES AND SPECIAL NEEDS. WE ALSO PAY THE SCHOOL FEES, UNIFORM COSTS, AND BUY THE BOOKS FOR AN ORPHAN DAVIA KNIGHT. WE PAID THE MEDICAL EXPENSES RELATING TO CANCER TREATMENTS FOR A FINANCIALLY PRESSED COMMUNITY ACTIVIST.
