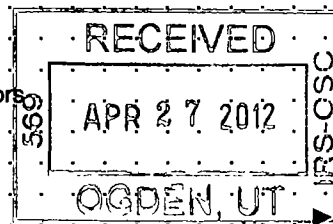

Pursuant to Article 9 Section 1 of the By-laws of the Fund for the Kilimanjaro Orphanage, an Alaska non-profit corporation, dated July 10, 2010, the Board of Directors makes the following amendments to said Bylaws.

Article 2 Section 1 of these bylaws is amended to read:

SECTION 1 OBJECTIVES AND PURPOSES

The primary objectives and purposes of this corporation shall be: to provide financial support for the common necessities and educational opportunities of the homeless children of the Kilimanjaro Orphanage, Pasua area of Moshi, Tanzania, Africa. Additional purposes for which the corporation is formed are: 1) to provide financial support for activities and programs within the surrounding communities including, but not limited to acquisition of real property and construction of school and medical facilities, that will improve the physical mental and emotional well being of the children of the Kilimanjaro Orphanage; 2) to provide financial support for activities and programs within the surrounding communities including but not limited to educational, medical, food and occupational opportunities; and 3) to educate and inform the American public of the cultural, social, educational, medical and economic needs of the children of the Kilimanjaro Orphanage.

Article 6 Section 2 of these bylaws is amended to read:

SECTION 2 CHECKS AND NOTES

Except as otherwise specifically determined by resolution of the Board of Directors, or as otherwise required by law, checks, drafts, promissory notes, orders for the payment of money, and other evidence of indebtedness of the corporation shall be signed by the Treasurer or Treasurer designee.
