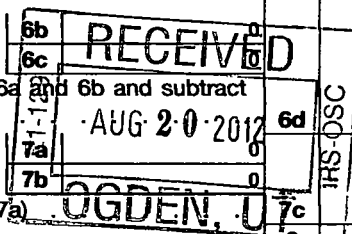

PART III, 31, Other program services: Amount of \$8,016 includes a range of small programs to promote village self-sustainability,

these programs include:

- agriculture assistance and livestock assistance (\$4,000)

- micro-credit (\$1,200)

- community leadership development and training (\$1,950)

Incidentally, the "Expenses" noted in 28a-31a are attribution of shared expenses on a pro-rata basis of % of funds designated to the program

\*\*\* Footnote (since I don't want to re-type the whole form): The reason that we have an "excess" where not all donations were distributed is because we were still validating portions of pending programs, especially chickens to provide a local source of protein (eggs) and beekeeping to provide employment and revenue as well as an alternative to sugar cane (sugar cane contributes to significant dental problems). These projects were validated and funded in First Quarter 2012 and the \$40,000 of donations was used to help the village.)
