


PROVIDES FINANCIAL SUPPORT TO THE DIOCESE TO PAY FOR PAYROLL EXPENSES, MEDICAL SUPPLIES AND EQUIPMENT PURCHASES OF THE CLINIC. KATERI MEDICAL SERVICES, INC.
