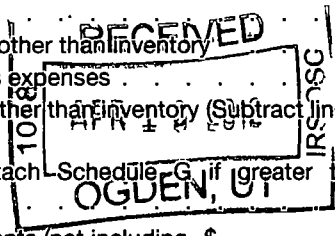



The results of the November 2011 workshops have been written up as papers, summarizing the consensus on standard policies, procedures and definitions for ITMIG to use in order to achieve consistency and make collaboration possible.

These papers have been through extensive debate and refinement, and were overwhelmingly accepted for adoption by the ITMIG membership. The final papers have been accepted for publication in a special issue of the Journal of Thoracic Oncology, and published as a special supplement in June 2011. This represents a huge amount of work, and is nothing short of a quantum leap forward in building a foundation to advance the science.

Cost of the Supplement: \$39750

**Details on Database Initiative:**

Under the leadership of Jim Huang, we are actively building both a prospective and a retrospective database. The retrospective database will be housed at CRAB (Cancer Research and Biostatistics), the organization that has handled the IASLC lung cancer database and stage classification analysis. This capitalizes on the experience CRAB has with retrospective data. We are trying to work as much as possible with existing interest groups as a whole, such as JART or the thymic group of ESTS. Articulation of the relationships that are to everyone's satisfaction is under discussion, and underscores the need for the Global Mediastinal Council.

The prospective database will be housed at HUBzero, capitalizing on the experience of Purdue University's experience with developing a highly interactive, open and integrated database. HUBzero and CRAB have been working together closely, as it is essential that conclusions suggested by the retrospective data actually hold true in the prospective database. Establishment of appropriate data-sharing agreements, which will include both CRAB and HUBzero as linked entities, is the next major step in this process.

Other Progress:

In December, the 2nd pathology conference for 2011 was held at the University of Heidelberg in Mannheim, Germany.

Further progress was made in identifying problem areas with the histologic classification

and trying to develop solutions for us moving forward. Additional work is ongoing now by email.

Well established, however, is the spirit of collaboration, focus on a goal, , and willingness to challenge existing thinking.

Plans for the 2012 ITMIG meeting are well underway. This will take place in Fukuoka, Japan on November 25, 26, in conjunction with the

APLCC (Asia-Pacific Lung Cancer conference) from Nov 26-28. The meetings are being planned as a very integrated joint event, and we

hope that ITMIG members will make use of the opportunity to attend the APLCC and vice versa for APLCC members. There will be

debates on controversial topics, innovative lectures, many updates on ITMIG activities and prizes for the best submitted papers.

The research committee has been active in developing concrete trials for ITMIG to pursue.

We are proceeding with a variety of research projects, ranging from simple studies that involve only a few

collaborators to a global randomized study, and involving traditional approaches and statistics to more novel designs. As soon as there is

more clarity about the regulatory and funding issues we will provide further details.
