Cambodia: A new facility was leased for the training center to train young Cambodians in Biblical truths. This is a live in training program. 11 graduated from the program in 2011. Renovations were also made in this new facility to accommodate the church worship on Sundays. A total of 150 adults and children attend the Sunday services. Ongoing ministry takes place in 4 other provinces with a total of 8 churches.

Selah Safe House. A new house was rented for the operation of a safe house for victims of trafficking. 6 children are cared for with a staff of 5 that includes, house manager, counsellor, etc.

Vietnam and Indonesia. A training center was established in Vietnam to train around 35 local leaders. We also have a training center in Indonesia that graduated 7 full-time students. A church and home group was also established in Indonesia.
