The grants provided various services, including veterinarian and medical services such as vaccinations, heartworm testing & treatment, spay/neuter operations, transport fees and overall care of homeless dogs and cats within the organizations. Overall costs range from \$25 to \$175. We estimate that services were provided to 100-150 animals. Spay/neuter services prohibited unwanted litters from being born and helped to end the suffering of animals that would otherwise end up in shelters which euthanize.

The mission of Second Life (SL) is to support animal rescue groups and charities in their goals of increasing adoptions of homeless pets and reducing pet overpopulation through spay/neuter programs. SL offers a high quality thrift shopping experience in a clean, organized retail environment with a focus on providing excellent customer service to encourage repeat business and word-of-mouth promotion.

Proceeds from the sale of donated items are used to support store expenses and to issue monetary grants to various animal shelters to support the mission of reducing euthanasia of adoptable pets and finding homes for homeless pets.
