PART III PROGRAM SERVICE ACCOMPLISHMENTS, PRIMARY PURPOSE:

The primary purpose of the Sanghata Foundation is to provide a hermitage, known as the "Pacific Hermitage" (the Hermitage) for members of the Abhayagiri Monastic Foundation, a California nonprofit religious corporation, renting real property, purchasing real property and maintaining real property in the State of Washington and supporting the alms-mendicant monks resident on that property. Support includes providing for all needs of the monks in residence as alms-mendicant monks. The Foundation acts as a steward for the Hermitage by soliciting and receiving money and goods from donors for the benefit of the Hermitage, transferring donated items for the Hermitage to the extent permitted by rules governing the Sanghata Foundation, the Abhayagiri Monastic Foundation and the resident monks, or, alternatively retaining ownership and making these items available for use by the residents at the Hermitage, and holding and administering money for the benefit of the Hermitage in accordance with donors' instructions.
