At African Road, Inc. we partner with local Rwandan leaders who help orphaned youth and widows in rural Rwanda for the purpose of poverty reduction. In these vulnerable communities we provide practical, hands-on assistance through financial aid, project planning, strategic thinking, and implementation of income generating businesses. For instance, we have partnered with Pastor Steven Turikunkiko in Gasogi village to purchase and develop a small farm and goat business for orphaned youth, and begin a tailoring business for widows.

The 80 Rwandan youth we assist, aged 11 to 25, were orphaned during the 1994 genocide or by HIV/AIDS. They live in poverty, renting small homes and living in child-headed households. Before African Road, they pooled what small income they could find through day labor to pay rent and food. They never had enough funds for school or health care. African Road received an \$88,000.00 grant from the Huddart Family Foundation to purchase land for the youth's income generating needs. With \$60,055.82, we purchased the land and began the business development process. We researched and partnered closely with people in the field who helped us purchase a 5 acre parcel of land for the youth, and begin developing it for agribusiness. In the next year, we plan to continue with development and assist the youth with training and business planning. Even now, they have a diverse crop, a goat raising business, and room to meet and play soccer. There is a well on the land, greatly improving the quality of their lives and health. Now with stable income, the youth have hope for their futures, school, health care, safer homes, and self-sufficiency.

African Road partners with two cooperatives in rural Rwanda: Togetherness Orphaned Youth Cooperative and New Destiny Widow's Cooperative.

We seek to assist their own efforts to move from poverty to self-sufficiency. Through a combination of emergency need relief, project planning

and funding, and micro-loan investment, we empower the 250 members of the two cooperatives. In 2011, we invested in a tailoring business for

the widows' cooperative by helping them find buyers for their products, repairing broken machines, and strategic business planning; we supported

the youngest orphans, under the age of 11, by financially supporting the family who cares for them, subsidizing their rent, food, school fees,

and medical care; and we coordinated and funded a mobile medical clinic project to provide care and health education to the two communities.
