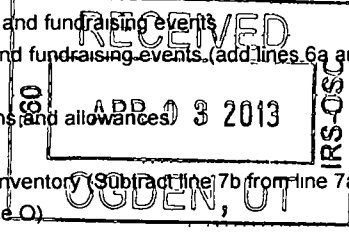




(the organization) was formed exclusively for charitable and educational purposes to provide for the needs of disadvantaged children. It recently expanded its charitable activities to include providing grants to support approved charitable activities and projects consistent with these purposes carried out by Kfar Yeladim David, Jerusalem, a recognized Israeli tax exempt charity.

Kfar Yeladim David, Jerusalem, is a home away from home for Israeli disadvantaged children. It works in conjunction with Israels Welfare Ministry, Education Ministry and the Jerusalem Municipality providing treatments and programs for children who are orphans, victims of abuse and neglect and other disadvantaged children to rehabilitate these children and mainstream them into society.

The Organizations Board of Directors (the Board) excercises complete discretion and control over this grant making activity and all funds solicited to support its grant making program. The Board will actively monitor all grants and require that each grantee including Kfar yeladim David Jerusalem furnish the organization with a periodic report and accounting to document that the grant funds were expended for the charitable purposes approved by the board.
