IN THE TIME SINCE MARCH 2010 THAT HOT HAS BEEN WORKING IN HAITI, THERE HAVE BEEN SIX FIELD MISSIONS AND THREE MONTHS OF CONTINUOUS SUPPORT. ADDITIONALLY, HUNDREDS HAVE BEEN TRAINED IN OSM THROUGH WORKSHOPS AND DATA COLLECTION PROGRAMS. AS A RESULT OF THESE ACTIONS, OPENSTREETMAP HAS BEEN PUT IN THE FOREFRONT IN HAITI. THE OPENSTREETMAP DATA HAD BEEN IMPROVED UPON AND STRONG CAPACITIES BUILT IN THE UN SYSTEM, PART OF THE HAITIAN GOVERNMENT AND IN THE CIVIL SOCIETY. THEREFORE, THE FOCUS OF HOT'S WORK IN DISASTER RISK REDUCTION (DRR) IN INDONESIA HAS BEEN DATA PREPAREDNESS. THE APPROACH IN THIS PILOT HAS BEEN TO FOCUS ON URBAN AND RURAL AREAS SEPARATELY. THE SCALE OF THE RESPONSE DEPENDS ON THE SIZE OF THE EVENT AND THE ABILITY OF HOT TO RESPOND EFFECTIVELY.
