FORTUNE FUND IS PAYING FOR THESE STUDENTS' BOARDING, SCHOOL FEES, UNIFORMS, AND BOOKS. LAST AUGUST 2011, S2TECH FORTUNE FUND CONTRIBUTED \$3,000 TO ZILLA PARISHAD HIGH SCHOOL IN KANUMOLU VILLAGE IN ANDHRA PRADESH, INDIA TO BUY 35 BENCHES FOR STUDENTS TO SIT AND WRITE THEIR NOTES. THE STUDENTS WERE SITTING ON FLOOR TO ATTEND TO THEIR CLASSES. ONE OF OUR EMPLOYEES, MR VENKAT GURUVELLI, WHO STUDIED IN THIS SCHOOL, CAME TO THE FORTUNE FUND BOARD TO HELP THE STUDENTS WITH NEEDED BENCHES. MR GURUVELLI ALSO INDICATED HIS INTEREST TO CONTRIBUTE \$1,500 TOWARDS THIS CAUSE. FORTUNE FUND BOARD LOOKED AT THIS PROJECT PROPOSAL AND AGREED TO TAKE UP THIS PROJECT. MR GURUVELLI'S CONTRIBUTION OF \$1,500 AND MR VEERLAPATI'S CONTRIBUTION OF \$1,500 WAS USED TO PURCHASE 35 BENCHES FOR THE SCHOOL CHILDREN.
