Collectively, the distributions in excess of current income totaled \$37,500. This amount represents over 25% of the Foundation's net assets of \$15,129 (as measured by fair market value) at the beginning of the Foundation's taxable year ending December 31, 2011. Although the Foundation technically experienced a "substantial contraction," it will continue in existence and has no plans for dissolution.

The Foundation made distributions of cash to the grantees listed in the attachment to Part XV, Line 3a, each such grant was made solely for the charitable purpose specified therein.

Amount Treated as Distributions out of Corpus to Satisfy Section 170(b)(1)(F)(ii)

Sanders Tech-Ed Foundation (the "Foundation") hereby elects to satisfy the requirements of Internal Revenue Code ("Code") Section 170(b)(1)(F)(ii) in respect of contributions of \$60,000 received in the taxable year ending December 31, 2011 (the "Conduit Election Year"). To satisfy the requirements of Code Section 170(b)(1)(F)(ii), a private nonoperating foundation must: (A) distribute its 2010 undistributed income by the end of the Conduit Election Year; (B) distribute, in the absence of an election under Code Section 4942(h)(2), its 2011 undistributed income by the end of the Conduit Election Year; and (C) make qualifying distributions treated as distributions out of corpus by no later than the 15th day of the third month of the taxable year following the Conduit Election Year in an amount equal to 100 percent of the contributions received by such foundation in the Conduit Election Year.

A. Satisfaction of Minimum Distribution Requirement for the Conduit Election Year. As reported on Part XIII, Line 2, column (c), the minimum distribution requirement for the Conduit Election Year is \$0. In other words, the Foundation had no undistributed income for 2010.

B. Timely Satisfaction of Minimum Distribution Requirement for the Taxable Year following the Conduit Election Year. As reported on Part XIII, Line 6f, column (d), the minimum distribution requirement for the taxable year ending December 31, 2012, the taxable year following the Conduit Election Year, is \$0. In other words, the Foundation had no undistributed income for 2011.

C. Sufficient Timely Qualified Distributions Made Out of Corpus. To satisfy the requirements of Internal Revenue Code Section 170(b)(1)(F)(ii), the Foundation had until March 15, 2012, the 15th day of the third month of the taxable year following the Conduit Election Year, to make distributions out of corpus in an amount equal to 100 percent of the contributions received by it in the Conduit Election Year, \$60,000.

1. As reported on Part XIII, Line 4, the Foundation made 2011 qualifying distributions of \$39,706, of which \$2,144 was applied to the 2011 distributable amount, as reflected on Part XIII, Line 4d, column (d), leaving a remainder of \$37,562 distributed out of corpus (the "Remaining 2011 Corpus Distribution"), as reflected on Part XIII, Line 4e, column (a) (\$39,706-\$2,144).

The Foundation has attached the necessary election, pursuant to Treasury Regulations Section 53.4942(a)-3(c)(2)(iv), to treat \$4,779, its total unused prior year's corpus distributions, as a current distribution out of corpus. This left a balance of \$17,659 to be distributed by March 15, 2012 (\$60,000-\$42,341).
3. This statement hereby confirms that the Foundation in fact made timely qualifying distributions in the amount of \$17,659 between January 1 and March 15, 2012 that will be treated as distributions out of corpus in connection with contributions it received in the Conduit Election Year.
