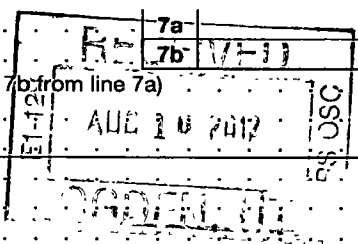





28. Addiction Support Groups- Tower21 has two sober living support groups that meet once a week. Between these two groups 189 people have been apart of these two services at one point or another. The addiction support groups are open to any one who wants to attend. No fee is collected and all meals and curriculum based material is free to the participants.

29. Employment Services- Tower21 has coached 76 people on preparing and obtaining employment with in the community. This includes resume building, filling out applications, skill set development and interview coaching. Once a week people that are looking for employment gather together in a support group to exchange ideas, leads and encourage others to keep looking for employment. A computer lab aids individuals for this service.

30. Living Assistance- Tower21 provides two months of living assistance when accepted into our sober living house. Participants are encouraged to volunteer at Tower21 or another agency. While in the program, participants live a sober life while rebuilding their lives. Tower21 has Tower21 has given 10 people this opportunity in 2011.
