Friends of Amani US Inc funds have been granted to Amani Centre for Street Children as they continue rescuing homeless children in Tanzania, East Africa and providing the nurturing care - education, food, medical, and a compassionate staff of teachers, social workers and care-givers - which will restore hope in their lives and help these most-vulnerable members of the community to become self-sustaining, independent young adults. All funds currently held by Friends of Amani US Inc have been approved to be granted to Amani Centre for Street Children as long as they continue meeting our Board-approved funding criteria and expectations as well as the intent of our donors, which our Board ensures with ongoing oversight.

4b (Code:) (Expenses \$ 4,428 including grants of \$ 0) (Revenue \$ 18,803)
Holiday Fund-raising Program - Friends of Amani US Inc solicited support for the Amani children with a holiday mailing and the sale of holiday cards. The expense associated with this program was for postage - distributing the cards by mail and mailing holiday letters requesting support, and for staff time. The cards themselves were designed and printed by volunteers at no cost to Friends of Amani US Inc. A volunteer set up a page on the Amani web-site to promote the sale of holiday cards and accept sales. Although Friends of Amani US Inc will continue the holiday mailing portion of this program, the holiday cards have proven to be a less-successful endeavor and will be discontinued as inventories are sold.

Fund-raising by Volunteers - Volunteers reaching out to their friends and families in their own communities and beyond is an important program for Friends of Amani US Inc and a vital source of ongoing funding. Amani's location at the foot of Mt. Kilimanjaro, has provided an ideal opportunity for volunteers to travel to Tanzania, climb the mountain and spend time volunteering with the children. Whether they climb or not, volunteers set up webpages with online fundraising sites, write personal emails /letters, have parties in their homes, all to raise awareness of the issue of homelessness, introduce their friends to Friends of Amani US Inc and our choice to support Amani Centre for Street Children and their wonderful programs designed to change the course of life for homeless children in Tanzania. The expenses involved with this program are primarily the fees charged by online sites, as well as some cost for stamps, paper (much of which is donated) and staff time to support the program and ensure its continued success.

Monthly Sponsorship Program - This program is ongoing and has a goal of establishing a dependable and sustainable funding source by asking donors to contribute at a specific level on a monthly basis. In return, monthly sponsors receive periodic personal updates, communications and pictures from Amani Centre for Street Children's staff and children. During the year, Friends of Amani US Inc has reached out to monthly sponsors to share an Operations Highlights Report from Amani exemplifying the impact their monthly sponsorship has had on Amani's ability to provide the nurturing care all children deserve in their lives. In addition, Friends of Amani US Inc tries to maintain an ongoing connection with monthly sponsors to ensure the continuation and growth of this vital program. The primary expense associated with this program is for processing fees (by PayPal and the bank). Additional expenses have been minimal - a volunteer set up promotional information and the ability to sign up on the Amani web-site, the cost of stamps and paper supplies (many of which have been donated) and staff time to support the program and ensure its continued success.

Scholarship Program - Friends of Amani US Inc fully supports the Amani Centre for Street Children goal of helping homeless children to become independent, self-sufficient young adults. Beyond this, we would like to see the Amani children soar to reach their full potential. Key to achieving this goal is a quality education. Realizing there are high-potential students at Amani who could do so much more in their lives than merely becoming self-sufficient, but understanding the financial realities of such a prospect, this program has been started to specifically address the needs of Amani's higher potential children - those who could be successful in better schools which cost more money, and eventually perhaps attend university. The Scholarship Program has been established and donors are being sought to support the idea of formerly homeless children realistically achieving their dreams. The expenses associated with this program, thus far have been for donation processing (PayPal and bank fees) and for staff time allocated to this program's ultimate success.
