These back packs were, in turn, donated to Grace Baptist Church (a 501c3 organization), at the fair market value of \$550. The back packs will be given to poor children living in Haiti during Grace Baptist church's short term mission to Haiti.

These funds were donated to the organization to pay for tuition for poor Assyrian children living in Jordan. \$6,020 was given to Global Partners in Peace and Development (GPPD, a 501c3 organization) in 2011. GPPD have and will use these funds to pay for private school tuition for Assyrian children living in Jordan.

\$1,500 of funds were donated to the organization and, in turn, given to Global Hope Network International (GHNI, a 501c3 organization). GHNI used the funds to purchase \$1,500 of back packs in Jordan, distributing the back packs to poor children living in Jordan.

\$750 of funds were donated to the organization and, in turn, given to Campus Crusade for Christ (a 501c3 organization). Campus Crusade for Christ used the funds to purchase school supplies for poor children in Ethiopia.
