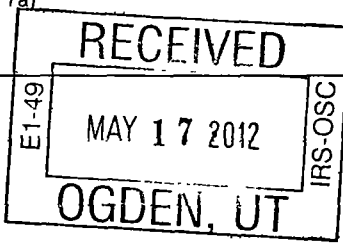





Sarcoma Warriors of the Upstate, Inc. has a primary mission to inform and educate people about a rare family of cancers called the sarcomas.

Sarcomas are a rare family of cancers affecting roughly 13,000 Americans every year. Limited research dollars are allocated to this type of cancer. Through private donations and fund raisers, the Organization raises funds to support patients who have been diagnosed with sarcoma cancers.
