The DC Diaper Bank partners with local social service agencies that currently have programs in which they serve clients in need of diapers. The DC Diaper Bank selects partner agencies, verifies the tax-exempt status of each agency, and requires the partner agency to complete an application and sign a contractual agreement regarding diaper distribution. The DC Diaper Bank, in conjunction with the Capital Area Food Bank, tracks the diapers distributed to the partner agencies and requires the partner agencies to provide information on their use of the diapers, such as, how many diapers were distributed, in which programs they were used, how many babies and families received diapers, and the zipcode in which clients that received diapers live. The DC Diaper Bank also conducts site visits throughout the year, and stays in close contact with the partner agencies. The DC Diaper Bank reserves the right to discontinue distribution to a partner agency that does not actively distribute diapers to clients in need or which breaches its contractual obligations with the DC Diaper Bank.

The DC Diaper Bank began distribution in April 2011. From April 2011 to December 2011, we distributed diapers to the following initial social service partner agencies: Healthy Babies Project (DC), Shabach Ministries (MD), Montgomery County Family Center (MD), Mazique Child Care Center (DC), Northwest Center (DC), SERVE/Northern Virginia Family Services (VA), Family Crisis Center of Prince George's County (MD), United Community Ministries (VA), Bull Run Uitenan Universalist (VA), Refuge Ministries (MD), and Bread for the City (DC). Each organization received between 5,000 and 15,000 diapers, with no one organization receiving total diapers valued at \$5,000 or more.
