

The Farm. As a Jewish urban farm, we are a transdenominational Jewish education center for the local Jewish community, reaching Jews of every age and denomination through our programs and vision of creating a more just and sustainable world. Even the Urban Adamah House for Fellows serves as a hub and a network to connect local young Jews, and offers community Shabbat gatherings and educational events on current Jewish eco-sustainability topics.

4b (Code:) (Expenses \$ 56,053 including grants of \$ 0) (Revenue \$ 0)
The Fellowship. The Urban Adamah Fellowship is a three-month residential leadership-training program for young adults that integrates urban organic farming, direct social justice work and progressive Jewish living and learning. The fellowship curriculum is designed to equip fellows with the tools to become agents of positive change in their own lives and in their communities.

4c (Code:) (Expenses \$ 130,790 including grants of \$ 0) (Revenue \$ 0)
The Education Center. Jewish Farming Summer Camp: In 2011, we ran an innovative Jewish farming summer day camp for children ages 5-12 for three weeks, in partnership with the Jewish Community Center of the East Bay, Congregation Beth Israel, Camp Tawonga and Congregation Netivot Shalom. In 2012, we are expanding the camp to seven weeks including an interfaith camp week and a spring break/pre-Passover camp week. Hebrew School on the Farm: In 2011, in partnership with the Kehillah Community Synagogue in Piedmont and Congregation Beth El in Berkeley we ran an afterschool Hebrew school program that integrated hands on farm activities, food growing and preparation and arts and music with Jewish tradition. We are offering the program again in 2012. Holiday Family Celebrations: Several times a year we offer day-long family programs that integrate themes of the Jewish holidays with experiential hands-on farm work and play. These celebrations of food, music, dance and learning are run in partnership with dozens of Bay Area Jewish institutions. Our last major event was for Sukkot in 2011. We had 450 participants for the day.
