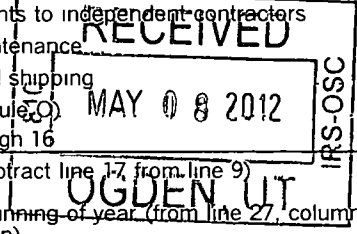

Around the globe, millions of children suffer at the hands of captors and abusers in the \$32+ billion "industry" known as human trafficking. In the United States alone, officials estimate that as many as 200,000 children are at risk of being trafficked each year. California is the only state that has three cities with a high incidence of child sex trafficking. During the Spring of 2010, a group of eleven friends joined together to raise awareness and money for the restoration of children forced into sex trafficking. More than half are runners and athletes so a 5/10K race called Run For Courage, seemed appropriate. After 2 races, Run For Courage has hosted over 2500 participants, countless volunteers, and many generous sponsors/contributors-and has raised approximately \$140,000.RFC attacks the crime of sex trafficking in several ways. First, we employ our experience and talents to put on large-scale events with participants and corporate sponsors. Second, we raise money for organizations that: Provide direct services that help restore victims. We choose programs that most efficiently utilize their resources on services for victims. Proceeds from our events will be distributed to multiple organizations, programs, residential facilities, or homes that have been carefully evaluated and monitored.
