Mazeppa Productions is a theater company that is devoted to advancing the art of musical theater in the Philadelphia area. Our company focuses on interpretations of well-known classic musicals and presentation of modern musicals. We also focus our efforts on theater designed to be enjoyed by the entire family. Our performance season is focused generally in July, when there is very little theater to be enjoyed in the city of Philadelphia.

Mazeppa presented a fully staged and realized reinterpretation of the Broadway classic, Pippin, in July 2011. As described above, the primary goal of our company is to provide high level musical theater to the Philadelphia community and to present this work in a new and imaginative manner. We accomplished this through our production. We chose to set our production in the technology age (rather than in Medieval times, as originally designed on Broadway). This allowed our audiences both to view this classic musical in a new light but also to analyze the ways in which technology is taking over modern life. We had more than seven hundred people attend our show, and our production was highly successful. This show also involved many local Philadelphia actors, musicians, and artists, which is another one of our major goals.

4b (Code:) (Expenses \$ 3880 including grants of \$ 0) (Revenue \$ gross \$2,619.00)

Mazeppa also presented a production of Dear Edwina, a new musical by an up and coming musical theater writing team. One of the major goals of the company is to present musical theater that can be enjoyed by the entire family all together. As with our production of Pippin, we worked with all local musicals and actors who helped to make our first production artistically successful. This season, more than 250 audience members enjoyed our production. We also coupled our theater productions with education for the audience members (most notably, the children in the audience) and meet and greets with the cast and musicians.

One of our other goals is to provide tickets to the theater to audiences who may not have access or the ability to attend. In support of this goal, we invited under-represented groups to enjoy our productions for free. This year, we provided almost 100 free tickets to ArtReach Philadelphia, which provides free tickets to music and theater to the handicapped and disabled. We also worked with local deaf organizations and provided an open captioning night free of charge. Finally, we are currently developing a program that will allow innercity camp groups to have the chance to experience live theater free of charge.
