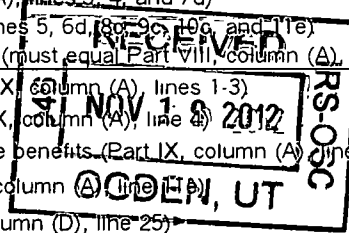

2011 Accomplishments: The Mack Road Partnership was approved in late 2010 and received its first round of funding in 2011. The key steps for the initial year included identifying and seating the inaugural Board of Directors, filling the key role of Executive Director and setting up the major program areas for the PBID. Since safety and security were identified as the major focus, key contracts were negotiated and put in place to address those concerns. In addition, office space was procured and outreach to the community and the local businesses was launched. Resources to identify the bullets for a strategic 5 year plan were located and the process of planning and building such a plan was begun.
