DURING THE YEAR THE FOUNDATION MADE TWO SET-ASIDE GRANTS MEETING THE CASH DISTRIBUTION TEST PURSUANT TO THE TERMS OF IRC 4942(G)(2)(B)(II) AND TREASURY REGULATION 53.4942(A)-3(B)(1). THE TRUSTEE OF THE FOUNDATION HAS SET ASIDE \$30,000 FOR THE UNIVERSITY OF MONTANA JOURNALISM SCHOOL FOR ACADEMIC SCHOLARSHIPS AND \$18,000 FOR MONTANA FISH, WILDLIFE AND PARKS TO COVER ANNUAL MAINTENANCE COSTS FOR THE MADISON BUFFALO JUMP HISTORIC SITE.

THE SPECIFIC PROJECTS FOR WHICH THESE FUNDS HAVE BEEN SET ASIDE ARE MULTI-YEAR PROJECTS THAT WILL NOT BE COMPLETED PRIOR TO THE END OF THE TAX YEAR. ADDITIONALLY, CERTAIN APPROVALS ARE PENDING WITH RESPECT TO THE PROJECTS FOR WHICH FUNDS HAVE BEEN SET ASIDE. AS A RESULT OF THESE FACTORS, THE PROJECTS AND RELATED DISTRIBUTIONS CANNOT BE COMPLETED WITHIN THE CURRENT PERIOD. AMOUNTS SET ASIDE DURING 2011 WILL BE DISTRIBUTED TO THE RECIPIENTS NO LATER THAN JUNE 30, 2016. ACTUAL CASH PAYMENTS FOR CHARITABLE PURPOSES WERE \$2,150 DURING 2010 AND \$1,300 DURING 2011.
