**Summer day camp: 60 youngsters participated in a day camp experience at a farm where they learned about horses, farm life while interacting with others from diverse cultural, social and economic backgrounds. In addition to summer recreational activities, campers also worked on equestrian related skill packs that helped improve academic performance in math, language and reading areas.**

4b (Code: ) (Expenses \$ 72,966 including grants of \$ 73,000 ) (Revenue \$ 73,000 )  
**Approximately 100 youngsters ages 11-18 participated in a 10-week spring program that taught equestrian related skills and academic enrichment activities that supported school based curriculum and targeted Connecticut Mastery Test areas. Classroom lesson activities included math, language, reading in horse related skill packs. Horseback riding and other horse activities were also provided. These spring cycle students participated in the 18th Annual City Slicker Horse Show in June.**

**Approximately 150 youngsters ages 11-18 participated in a year-round program that in addition to teaching skills in horseback riding, also provided academic and enrichment activities. Classroom lessons provided structured skill packs with horse related themes using math, language and reading skills in lessons that supported school based curriculum and targeted Connecticut Mastery Test areas. All program activities were designed to promote improvement in academic and interpersonal/social areas. Team Florida riders participated in the annual trip to the Winter Equestrian Festival in Wellington, FL.**
