ACCOMPLISHMENTS IN 2011In 2011, DreamPower provided services to 455 individuals, including 189 children (ages 4-12), 71 teens (ages 13-17), 43 transition-age youth (ages 18-24) and 152 adults (ages 25-84) 175 children and teens living in group homes, residential treatment programs and low-income or at-risk families received equine facilitated mental health, therapeutic or educational services paid for by donations to DreamPower during 2011 190 adults received services paid for by donations to DreamPower in 2011 These included parents of at-risk youth, parents in the "Ponies, Pumpkins and Parents" parenting skills group and veterans and military service members and their families in the Horses for Warriors program In 2011, more than 410 volunteers donated over 13,000 hours of volunteer time and labor to DreamPower DreamPower receives volunteer support from the Morgan Hill Kiwanis, San Martin Lions Club, South Valley Community Church, Morgan Hill Bible Church, Pacific West Christian Academy, Lucent Technologies, IBM, Google, Cisco, Gavilan College, San Jose State University, and Gilroy and Morgan Hill Girl Scouts, Boy Scouts and 4-H DreamPower has had volunteer interns from Notre Dame High School, San Benito High School, Bethany University, John F Kennedy University, Brigham Young University-Idaho and Western Seminary In 2011, DreamPower Horsemanship received two awards of national significance These competitive awards demonstrate that the quality of DreamPower's programs and services is recognized nationally and internationally First, Tulips, a 22-year-old American Quarter Horse mare that works full-time at DreamPower, was selected by a national committee as the Region 11 Horse of the Year for the Professional Association of Therapeutic Horsemanship International (PATH Intl) Region 11 consists of California, Nevada and Hawaii This selection is a competitive process where a committee from around the U S evaluates nominations "blindly" (with no identifying information) on the basis of the horse's years of service, types of therapeutic activities they participate in, work load, attitude, health, contribution to the program and letters of recommendation from program staff, volunteers and program participants and their parents or caregivers Through this process, Tulips was selected as the 2011 Region 11 PATH Intl Horse of the Year Also in 2011, Martha McNiel was selected as the 2011 PATH Intl Equine Facilitated Psychotherapy and Learning Professional of the Year This award is also a competitive process where a committee of professionals from around the world evaluates nominations "blindly" (with no identifying information), based on a scoring system of the nominee's professional practices, contribution to the field, variety, history and quality of professional services, knowledge of safe and ethical partnering with horses and letters of recommendation from other professionals in the field Martha McNiel was selected from nominees around the world to receive this award because of the quality, variety, creativity and quantity of professional services that DreamPower staff and volunteers provide to our community She received this award at the PATH Intl conference in Lexington, Kentucky in November 2011
