Each year, the Foundation selects worthy applicants who have demonstrated their commitment to public service by representing the underserved, disenfranchised, and indigent in our community. The Foundation provided \$142,756 in tuition assistance to attorneys who could not otherwise afford to attend a NITA program.

Program Services. The NITA Foundation also supports NITA publishing and customized program efforts.
