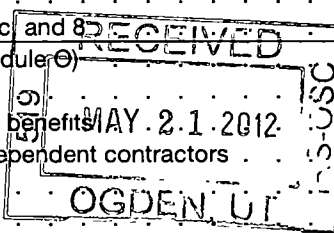

SURVIVAL OF NOT ONLY THE SPECIES, BUT OF ALL BIG CATS ON THE ATHI KAPITI.
