Briefly describe the organization's mission or most significant activities:

The Daughters of Mary of Nazareth (the "Community"), Inc is a Roman Catholic religious community of women. It is a private association of the faithful in the Archdiocese of Boston and was founded in 2011 by Mother Olga of the Sacred Heart. Like many religious communities, the Community follows the traditional states of formation: Aspirancy, Postulancy, Novitiate, Simple Vows, and Perpetual Vows. As part of their training in Religious life, Community members are exposed to various ministries that reflect the Charisma and the Spirituality of the Community. Since December 9<sup>th</sup>, 2011, the current Sisters have accompanied Mother Olga at the following ministries and services:

- 1) Prison Ministry – Mother Olga travels regularly to various correctional facilities within the Archdiocese of Boston and the Springfield Diocese. The Sisters visits these facilities to give talks, retreats, and pastoral care to the inmates. These visits occur approximately once a month.
- 2) Hospital, Nursing Home and Homeless Ministry – Mother Olga also visits various hospitals, nursing homes, and those who are homebound to offer spiritual consoling, bring Holy Communion to the sick, and prayer services to those who are unable to go to the Church. Currently, the Sisters are preparing for training to serve in these roles at a local hospital and nursing home in Newton, Massachusetts. This will allow the Sisters to have a professional training for hospital ministry. The Sisters also try to regularly visit homeless individuals who are in need.
- 3) Parish and Youth Ministry – Mother Olga travels for talks and retreats to young adult and youth, sometimes on a weekly basis, within the Archdiocese, and once a month outside of Massachusetts. The Community also offers youth retreats, religious education, and spiritual direction to our local parishes.
- 4) Schools, Universities, and Catholic Business Organizations – Mother Olga has a monthly speaking engagement schedule, in which speaking engagements she discusses the work of the Community and its message.
