With the help of a number of committed community volunteers, we were able to complete our Value of Education website in 2011 as a robust one-stop informational site for families who want their children to succeed in school. As part of that website, we've highlighted a group of Marion County "Education All Stars" These are folks who have gotten all or part of their education in Marion County and gone on to become a success. By sharing their stories, we are helping Marion County children to see the possibilities available to them through education. Plans are to expand the website so that both children and teachers can nominate those who are educational heroes to them. Take a minute to visit the site yourself at [www.itsyoursforlife.com](http://www.itsyoursforlife.com). Because of our work in education, we were asked in 2011 to take a leadership role in the newest version of Marion County's EnVisioning the 21st Century. When county residents identified education as a vital piece of our community's plan for the future, United Way's Value of Education work was recognized as the logical choice to lead the educational planning process. We continue to cooperate closely with other committees working on environment, social services, transportation, economic development and more to lay the groundwork for a prosperous and sustainable future for our children. In 2011, United Way adopted the Bridges Out of Poverty movement as the flagship of our Income Impact initiative. We partnered closely with Marion Municipal Court, Marion General Hospital and others to create and sustain a full-time Marion Matters organization- Marion's version of the "Bridges" work. The program has produced more than 40 graduates of extensive coursework, designed to teach participants how to change their circumstances, and matched them with community volunteers to mentor them as they complete their plan for change. Our next step in the process is to track outcomes and measure long-term success for the program. We also adopted Pioneering Healthy Communities in 2011 as our Health Impact initiative cornerstone. The Marion Family YMCA and other Pioneering Healthy Communities partners are working to promote policy, system and environmental change that will improve the health of our children. United Way has become a strong partner in finding both short-term and long-term solutions to childhood obesity and its eventual consequences. We also recently voted to provide a significant portion of the needed funding to complete the Center Street Community Health Clinic building. In mid-2011, we also became United Way of Wyandot County when the United Way of Upper Sandusky & Pitt Township closed their doors due to lack of financial and other resources. We were asked to step up and walk the Live United talk by helping our neighbors with professional staffing and operations. We look forward to strengthening both counties through shared talent and services.







