EnterMission has helped to provide various community development initiatives in India as a component of the holistic church planting methods that Entermission coaches (including the provision of clean water, literacy and education resources, construction programs for housing and community health/sanitation, health and hygiene education, etc) Finally, The Rhema Project (TRP), which exists as a project of EnterMission to intercept and halt the practice of female infanticide and feticide in Southern India, reports that in the past calendar year, it has Funded the construction of a school for pre-school and kindergarten children at Bethel AFC in Danishpet, India School serves 600 children from orphanage as well as neighboring villages Nearly 175 children attend Funded a teacher fund at Bethel AFC for its matriculation school Fund helped increase teacher compensation by nearly 20% allowing salaries to increase to 75% of government paid teachers Funded a scholarship program for 28 students attending Bethel AFC's vocational college 23 young women and 5 men received scholarships 21 women enrolled in the school of nursing assistants and 7 students enrolled in an office management track Funded the staffing costs to employ five (5) Indians to oversee TRP's Prenatal & Newborn Care initiative and Foster Care program 52 families participated in the Prenatal & Newborn Care initiative and 32 birth families having baby girls have continued receiving benefits and instruction through the program 24 families have been identified, trained and an abandoned girl baby has been placed with foster families 18 families have received monthly support (up to \$35 per month) to help offset costs for food, clothing and medical care of infant girl Within 12 months of the placement nearly 75% of foster families have requested that their monthly stipend be redirected so that additional abandoned or orphaned girls be rescued and place with more families A Foster Training curriculum has been developed to be included in training of pastors and targeted churches 38 village girls participated in an after-school tutorial program and summer and faith enrichment program
