CareSource is a nonprofit Medicaid health insuring corporation with over 20 years experience providing services to 875,000 members in Ohio The organization provides services through a contract with the Ohio Department of Job and Family Services ("ODJFS") CareSource is URAC accredited as a health plan and health call center In 1989, CareSource pioneered the state's first mandatory Medicaid managed care program in Ohio The organization has experienced significant growth in the 20 years that it has operated and is now the second largest Medicaid managed care plan in the country Over that time CareSource has garnered 52% of the state wide managed care market share CareSource spends over 96% of capitation revenue on program related expenses serving its Medicaid members CareSource has the highest voluntary enrollment rate and the lowest voluntary disenrollment rate of all participating Medicaid Managed care plans in Ohio Currently, the programs serve Covered Families and Children Medicaid, including Healthy Start and Healthy Families, and Aged, Blind or Disabled Medicaid members In addition, CareSource has a contract with the Center for Medicare and Medicaid Services ("CMS") to operate a Dual Eligible Medicare Advantage/Special Needs Plan called CareSource Advantage, available to those who are eligible for Medicare Part A and Part B, as well as Medicaid At the core of its mission, CareSource focuses on prevention with a goal of improving member health, the quality of the health care, and accessibility of health care services for Medicaid consumers via an innovative health and wellness methodology CareSource has a broad, state-wide network including many primary care and specialist physicians, hospitals, nursing facilities, home health care agencies, and other medical providers who provide medical care as well as assist in the coordination of member care In addition, CareSource offers 24 hour call center coverage to provide around the clock medical advice to help members access appropriate care when they need it CareSource reaches out to members, in their homes and communities, through case management and outreach services, to assess needs and to help coordinate their care with the healthcare system From high risk pregnancy to member education and advocacy, personal interaction proves crucial in coordinating the needed medical and community support services Member and provider communication provides additional health information CareSource has provided enhanced benefits to its Members which are in addition to required benefits by ODJFS for Ohio Medicaid Managed Care Plans In order to ensure the Member is able to access the most appropriate medical care, CareSource provides transportation services to a medical provider's office In addition, CareSource does not charge any Member a co-pay for any pharmacy product, dental visit, vision examination, vision hardware or non-emergent emergency room visits Finally, pregnant Members can participate in the "Babies First" Member Incentive Program to incentivize that moms-to-be receive early and on-going prenatal care All told, in 2011, CareSource paid approximately Nine Million Nine-Hundred Dollars (\$9,900,000) above the required Ohio Medicaid Managed Care Program Benefits in order to make a difference in the lives of underserved people by improving their health care In the spirit of CareSource's commitment to its charitable purposes, its appointed trustees and committee members earn charitable credits for each meeting attended At year-end, the trustees and committee members designate their credits to their Internal Revenue Code Section 501(c)(3) tax exempt charity of choice Charitable donations in the amount of \$51,000 were paid or accrued in 2011 under this Policy by the organization CareSource is a supported organization to The CareSource Foundation, a related Internal Revenue Code Section 501(c)(3) tax exempt organization The CareSource Foundation provides opportunities to advance innovative solutions and address healthcare needs of the underserved through grants, outreach, medical expertise, strategic community partnerships and volunteerism The Foundation funds responsive grants for targeted areas of need, which are given to individual non-profit organizations or a collaboration of non-profits through a single year grant The CareSource Foundation also funds signature grants with numerous regional, state and/or national partners all focused on creating sustainable, high-impact change in one of two key areas childhood obesity and programs to support basic health needs for the uninsured
