HOUSING - HOMEFULL ASSISTS PERSONS MOVING FROM HOMELESSNESS TO HOUSING WITH SHORT TERM AND ONGOING SUPPORT TO ACHIEVE HOUSING STABILITY. THE ORGANIZATION CAN ASSIST IN OBTAINING FURNITURE AND HOUSEHOLD ITEMS. ONCE HOUSED, CASE MANAGERS MEET WITH CLIENTS ON A REGULAR BASIS FOCUSING ON AREAS SUCH AS BASIC LIVING SKILLS, PARENTING, BUDGETING, PHYSICAL HEALTH CARE, SUBSTANCE ABUSE, MENTAL HEALTH COUNSELING AND ADVOCACY WITH OTHER AREA AGENCIES. THE ORGANIZATION PARTNERS WITH MANY COMMUNITY ORGANIZATIONS TO PROVIDE SUPPORTIVE HOUSING SERVICES FOR SEVERAL LOCAL MULTI-UNIT HOUSING PROJECTS. HOMEFULL ASSESSED, TRIAGED AND/OR CASE MANAGED OVER 1,000 HOUSEHOLDS IN THE GATEWAY SHELTERS. IN HOMEFULL'S GATEWAY PROGRAMS OVER 800 HOUSEHOLDS WERE HOUSED POSITIVELY. MANY EXIT TO PERMANENT HOUSING OPTIONS SUCH AS FAIR MARKET RENT, PERMANENT SUPPORTIVE HOUSING, OR MOVING IN PERMANENTLY WITH FRIENDS AND FAMILIES. LESS THAN 20% RETURN TO HOMELESSNESS.

SHELTER SUPPORTIVE SERVICES - HOMEFULL CASE MANAGERS WORK ONE-ON-ONE WITH CLIENTS IN SHELTER, WITH THE PRIMARY GOAL OF MOVING THEM INTO APPROPRIATE HOUSING, AND OUT OF THE SHELTER SYSTEM, AS QUICKLY AS POSSIBLE. CASE MANAGERS ASSIST CLIENTS IN SETTING GOALS, ADVOCATE FOR CLIENTS TO ACCESS OTHER COMMUNITY RESOURCES, ASSIST IN HOUSING SEARCHES AND MONITOR CLIENTS' PROGRESS IN ATTAINING GOALS. THE ORGANIZATION ALSO PROVIDES EDUCATIONAL CLASSES FOR SHELTER CLIENTS IN AREAS SUCH AS BASIC LIFE SKILLS, HOUSING, EMPLOYABILITY AND COMMUNITY RESOURCES. THROUGH HOMEFULL'S ASSESSMENT, TRIAGE AND HOUSING FOCUSED CASE MANAGEMENT WE SERVED OVER 1,500 MEN, WOMEN AND CHILDREN IN THE COMMUNITY'S GATEWAY SHELTER. MOST WERE PROVIDED ASSISTANCE RANGING FROM HYGIENE PRODUCTS TO START UP HOUSEHOLD ITEMS. HOMEFULL FOCUSES ON AREAS SUCH AS BASIC LIVING SKILLS, PARENTING EDUCATION, LITERACY AND PHYSICAL AND MENTAL HEALTH CARE. OVER 600 HOUSEHOLDS RECEIVED A BASIC START UP KIT ONCE HOUSED BY HOMEFULL.

HOMELESSNESS PREVENTION - HOMEFULL ASSISTS LOW-INCOME RESIDENTS WHO ARE AT RISK OF HOMELESSNESS DUE TO EVICTION OR UTILITY DISCONNECT. OUR OBJECTIVE IS TO KEEP PEOPLE IN THEIR APARTMENTS AND OUT OF THE SHELTER SYSTEM. THIS PROGRAM IS DESIGNED TO WORK WITH PEOPLE WHO HAVE FALLEN BEHIND IN THEIR RENT AND/OR UTILITY PAYMENTS DUE TO JOB LOSS OR OTHER UNEXPECTED CRISIS, BUT WHO NOW HAVE A SOURCE OF INCOME AND CAN GET THEMSELVES BACK ON TRACK WITH ASSISTANCE. OVER 250 HOUSEHOLDS WERE PROVIDED WITH ASSISTANCE TO PREVENT THEM FROM BECOMING HOMELESS AND ENTERING INTO THE SHELTER SYSTEM. OF THOSE 83% REMAINED HOUSED WITH ONLY 17% ULTIMATELY BECOMING HOMELESS.
