People who give through workplace campaigns can designate their donations to specific agencies within Community Shares or they can make undesignated gifts which are divided among the member agencies.




Workplace campaigns have proven to be a time and cost-effective method of raising funds from individuals. The campaigns are able to reach a large number of people with information about services within the community. This method also increases the resources available to the community by adding more nonprofit organizations to the campaigns and includes employees of all income levels while making philanthropy more diverse and democratic.
