The mission of Quivira is to build resilience by fostering ecological, economic, and social health on western landscapes through education, innovation, collaboration, and progressive public and private land stewardship.

Quivira holds a major annual conference, which is an important forum for the radical center, and which brings together a large and diverse group of people seeking both practical and positive solutions. This program also includes workshops, books, awards, and newsletters to promote progressive ranch management, scientifically-guided riparian and upland restoration, land health assessment and monitoring, and bridge-building among ranchers, environmentalists, government agency personnel, and the public.

4b (Code) (Expenses \$ 284,795. Including grants of \$) (Revenue \$)

Land and Water Program - Quivira's commitment to land health, restoration, collaboration, and progressive stewardship of natural resources. Program has included a variety of work ranging from induced meandering projects to grassbanks and local food production. Presently, the program concentrates geographically in north-central New Mexico, Quivira's Red Canyon Reserve in southern New Mexico, and in the Santa Fe, New Mexico area. Quivira also participates in various committees and coalitions that are also committed to implementing land health projects. Land restoration projects include Comanche Creek, Dry Cimarron, Canon Bonito, Mora River, Ponil Creek, and Cedro Creek projects.

4c (Code) (Expenses \$ 235,917. Including grants of \$ 80,050.) (Revenue \$)

Capacity and Mentorship Program is comprised of two areas. The Tribal Partnership Program is a collaboration with the Ojo Encino Chapter of the Navajo Nation to rebuild resilience in both the biological and cultural environments of the Navajo Nation. Principally this is done by helping the Chapter develop the capacity to plan and implement ecological restoration projects, manage a feral horse population, re-engage youth, learn from elders, and build capacity in a Navajo nonprofit called Hasbidito. The New Agrarian Program (formerly Conservation and Ranch Leadership and Youth - CARLY) is a program to create apprentice and internship opportunities for the next generation of conservation and agrarian leaders. Quivira has partnered with a number of sustainable agriculture operations around the Southwest, and
