

Simon Kenton Pathfinders' primary purpose is to build and maintain a multi-use trail and to provide trailside amenities for the multi-use trail which links Champaign County, OH to the Ohio & Erie Trail.

**Part III 28 Statement 2**

Through the support of the Champaign County community and surrounding areas in the form of donations and volunteer help, regular trail maintenance occurs including mowing, clearing and making minor repairs. The maintenance efforts of the Simon Kenton Pathfinders assists both the Champaign County and City of Urbana governments. Fundraising efforts over the past years raised monies to provide sealcoating of 1/2 of the existing trail. Monies are continuing to be raised for long term maintenance which will include additional sealcoating and eventual replacement of the approximate 10 miles of paved trail that directly links over 50% of the City of Urbana. An estimated 150,000 people use the trail annually providing a safe travel alternative and an added healthy lifestyle benefit. It is now possible to travel by trail from Urbana to Cincinnati, Ohio. In past years, a variety of fundraising events were conducted in order to raise monies needed to assist the City of Urbana with the purchase and renovation of a former railroad depot to provide trailside restrooms, rest area and parking for the public. The funds were also raised to assist both Champaign County and City of Urbana with the maintenance of the established trail. An estimated 150,000 people use this trail annually.

The fundraising events that were conducted also raised monies to continue assisting the City of Urbana with the maintenance of a former railroad depot to provide restrooms, rest areas, bike lockers and parking for the public. Volunteers continued fundraising for an extension of the multi-use trail northward, eventually adding an additional 18 miles. This will provide access to two additional communities, their businesses, schools and points of interest.

Fundraising events during 2011 focused on this trail expansion as well as the additional phases. The additional phases will provide access to 2 communities, their businesses, schools and points of interest. This expansion is projected to add an additional 30,000 people to the current estimated 150,000 people using the trail annually.
