 - b. Funding and promotion of interactive workshops aimed at 11th and 12th grade students to assist the students in preparing for their college entrance exams
 - c. Funding and promotion of interactive workshops aimed at 11th and 12th grade students to assist the students in the college application process
 - d. Funding and promotion of college nights aimed at all interested students featuring local and regional colleges and universities
 - e. Funding and promotion of mentoring program pairing local college and university students with a group of interested 11th and 12th grade students to provide encouragement and guidance in the college selection and application process

B. Phase II

1. Objective: Provide financial assistance and guidance to qualified applicants who are enrolled in college or university education
2. Target group: "Qualified" individuals who have graduated from a Miami Valley public school, focusing primarily on inter-city schools

3. Programs to achieve objective of Phase II
 - a. Educational grants to defray costs of college or university education
 - b. Mentoring program pairing educational grant recipient with professional member of the community to provide guidance and support

II. Criteria for Participation

A. Phase I

1. Foundation will send questionnaires to all Miami Valley public schools explaining program objectives to generate interest in programs
2. Foundation will work with interested public schools to promote programs among economically disadvantaged segment of student population
3. All interested students in target group are eligible to participate in programs

B. Phase II

1. Participation criteria: "Qualified" applicant must be:
 - a. A full time student at accredited college or university
 - b. In good academic standing
 - (1) For applicants applying for grant for first year of college, applicants' high school transcripts must demonstrate appropriate academic credentials
 - (2) For all other applicants, applicants' college or university transcripts must demonstrate appropriate academic credentials
 - c. Economically disadvantaged (i.e. without other substantial financial means to pay for costs of college including scholarships and grants)
2. Selection criteria: In awarding educational grants, selection committee should consider
 - a. Financial need of applicant
 - b. Academic credentials

c. Extracurricular activities aimed at furthering preparation for and success in college, including employment, civic groups, etc.

d. Written recommendations

e. Applicant's presentation of educational and personal goals in personal interview

f. Applicant's willingness to participate in implementation of Phase I programs

3. Selection committee will consist of a member of the local business community, a local high school principal or other educator, and a local college or post-graduate student (preferably a student who participated in Phase I and/or Phase II)

4. Educational grant will be paid directly to the recipient's college or university on behalf of the recipient to be applied toward the recipient's tuition

5. Educational grants will be in amounts ranging from \$1,000 to \$10,000 per year per recipient depending on recipient's financial need

6. Foundation anticipates awarding five (5) to ten (10) educational grants per year

III. Implementation and Supervision of Programs

A. Phase I

1. Meet with principals of participating Miami Valley public schools semi-annually to discuss current programs and ways to improve programs to better achieve objectives

2. Meet with participants of programs to discuss current programs and ideas for alternative programs

3. Meet with former participants of Phase I programs who have enrolled in secondary education to discuss ways to improve programs to better accomplish objectives

B. Phase II

1. Educational grant recipients must submit a transcript for the preceding academic year to the Trust by July to be considered for educational grant for succeeding academic year

2. Educational grant recipients must meet with the selection committee after the close of the academic year to discuss ongoing qualification for and receipt of

educational grant and to discuss post-graduate plans

3. Failure to submit transcript and/or failure to meet with the selection committee subjects the recipient to termination from participation in Phase II

IV. Endowed Scholarship Fund

The Foundation may also consider making contributions to charitable donees (pursuant to Article 3(d) of the Foundation) in the form of endowed scholarship funds at institutions of higher education such as the University of Dayton. A sample endowed scholarship fund for this purpose is attached.

KURT E. AND LOIS J. WALLACH FOUNDATION ENDOWED SCHOLARSHIP FUND

The Kurt E. and Lois J. Wallach Foundation Endowed Scholarship Fund is established at the University of Dayton to assist deserving students who are enrolled and pursuing courses on a full-time basis at the University of Dayton.

The donors wish that scholarships be awarded to worthy students without regard to race, gender or religion, as determined in accordance with the procedures and practices established by the President and the Board of Trustees of the University of Dayton. Preference will be given to economically disadvantaged students, including African-Americans and members of other minority groups. The selection of recipients is to be made by the University Scholarship Committee in coordination with the Financial Aid Office.

The first scholarship(s) will be awarded for the academic year following establishment of the Fund, after interest has been earned for approximately one year. Only income earned on the principal of the Fund is to be used for Scholarship awards, if such income is sufficient that year to meet the following terms.

As an endowed scholarship fund, only a portion of these earnings will be awarded each year, consistent with the policies and procedures as approved by the University's Board of Trustees. The remainder of the earnings of the Fund will not be awarded in order to achieve some growth of the principal. Accrued earnings prior to the first award will be added to the principal of the Fund. In subsequent years, any earnings over and above the approved spending policy of the Board of Trustees will be added to the principal of the Fund. Additional gifts are invited, and these will also be added to the principal of the Fund.

Financial administration of the Fund will be at the discretion of the University of Dayton, in accordance with its established procedures and practices. The donor will be advised as soon as practical about each recipient who accepts a scholarship from the Fund.

If changed circumstances should at some future time render the designated use of the Fund no longer appropriate, then the President and the Board of Trustees, giving consideration to the interest of the donors, as evidenced by the purpose described above, shall distribute the Fund income and principal to further the objectives of the University of Dayton.
