THE INTENT OF THE INSTITUTE IS TO PROVIDE A FORUM FOR TEACHERS TO DIRECTLY CONNECT TO BUSINESS EXPERTISE. THE BUSINESS PEOPLE DEMONSTRATE HOW SUBJECTS SUCH AS MATH, SCIENCE, COMMUNICATIONS AND MORE ARE ACTUALLY APPLIED IN THE BUSINESS SETTING. THE LTI PROVIDES TEACHERS AN EXCELLENT FORUM IN WHICH TO GAIN INSIGHT INTO THE APPLIED SIDE OF WHAT THEY TEACH AND INCORPORATE MORE RELEVANT EXAMPLES AND INFORMATION INTO THEIR RESPECTIVE CURRICULUMS. MORE THAN 200 STUDENTS HAVE ATTENDED THE ELI IN THE LAST EIGHT YEAR. THE PAST SUMMER, 24 JUNIORS AND SENIORS FROM ALL FIVE HIGH SCHOOLS IN FAYETTE COUNTY PARTICIPATED IN 2010.
