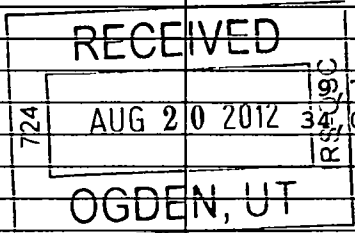

The Foundation provides scholarships to Christian Students in Hawaii. Scholarship recipients in 4-year college programs are awarded \$3,000 annually, or a total of \$12,000 in four years while recipients in 2-year college programs are awarded \$1,500 annually, or a total of \$3,000 in two years. In the last seven years, the Foundation has provided a total of 507 scholarships, amounting to over \$1,500,000. Scholarship checks are issued directly to the scholarship recipient's school.

All applicants are reviewed by a Scholarship Committee comprised of ten members from the community. They are scored in eight separate areas by at least three reviewers. The scholarship is renewable for up to three years, requiring a copy of the candidate's transcript to substantiate GPA and a minimum of twelve credits per semester and a personal letter from the student.

The initial applicant pool is reviewed by the Hawaii Community Foundation. They submit a list of candidates that have completed and submitted all required documentation.
