1. ***Foundation's Charitable Activities by Ms. Jacquelin Cochran (Foundation Project Manager).*** The Allen Foundation (the "Foundation") was formed on April 25, 2000, for the purpose of providing humanitarian and development aid to individuals in the most desperate areas of the world. To accomplish its charitable purposes, the Foundation began work in Cambodia, a country that has suffered almost unimaginable devastation and poverty for over three decades.

The Foundation's Project Manager, Jacquelin Cochran, holds a degree from Pomona College in Public Policy and Physics and received graduate training through the Energy & Resources Department at the University of California at Berkeley where she specialized in the use of water purification and renewable energy technologies in South-East Asia. She also has relevant work experience through her role as a Peace Corps volunteer from 1997 through 1999.

2. ***Joint Venture with Stung Treng Women's Development Center (SWDC).*** A joint venture in Cambodia's Stung Treng province was undertaken with Stung Treng Women's Development Center (SWDC) to reduce poverty by developing village-based sericulture which will enable local farmers to raise silkworms on mulberry trees, harvest and refine silk locally.

This endeavor was commenced through an agreement dated November 10, 2006 with the total funding commitment from the Foundation being \$181,170, \$6,000 of which paid in 2006, \$50,000 paid in 2007, \$42,170 during 2008, \$18,320 in 2009, and \$40,280 during 2010. The foundation has also paid \$24,400 during 2011.

Between 2002 and 2011 SWDC has directly supported over 520 women, 742 children and directly assisted many families in the impoverished Stung Treng region of Cambodia. The SWDC programs now include:

- Education Program in Literacy and Health
- Education Program School Sponsorship
- Vocational Training in Traditional Weaving and Sewing
- Vocational Training in Carpentry and Building
- Vocational training in Sericulture
- Support Program in Child Care
- Employment at SWDC production center for Mekong Blue
- Employment at SWDC café and gallery
- Employment at SWDC Sericulture program

Free Lunch Program for workers

Establish housing and transportation for children with medical needs

The August 2011 agreement with SWDC was funded with \$24,400. The purpose of the August 2011 agreement was to help SWDC obtain financial self-sufficiency through increased awareness and sales of its silk products in the Cambodian and international markets through their Phnom Penh store. The store was set up in 2009. In 2009 Mekong Blue also launched its first online store in the US. Mekong Blue has been invited to display products and sell at the conference of Asian Leaders Meeting in October, 2012 and has also been selected to attend the Folk Art Market in Santa Fe, New Mexico, a unique market that only selected Artists who make traditional and high quality products to support their own community.

Additionally, the August 2011 agreement provides support to carry out networking engagements and capitalize on new contracts with governments, NGO's, tourist industry, designers/technicians, suppliers and potential buyers. Amounts were requested for the hiring of one additional sales manager for the purpose of managing logistics and inventory between Phnom Penh and Stung Treng and managing the Stung Treng café and gift shop. The agreement also includes amounts requested to be used in the mission of increasing the overall health of the community members by providing housing and transportation for children from Stung Treng who required medical attention in Phnom Penh.
