Creative Cauldron offered 6 sessions of Arts Adventure in 2011 for a total of 11 weeks of programming. Sessions included SPRING CAMP (4/18-22/2011), ARTS ADVENTURE SAMPLER (6/27-7/8/2011), OVER THE RAINBOW (7/11-29/2011), CIRCLES AND CYCLES (8/1-19/2011) and A WORLD OF MUSIC (8/22-9/2/2011). This was the tenth year for these camps that combine the performing and visual arts with an exploration of the natural world. 186 children ages 4 through 14 participated in these programs. 5% were scholarship students who received reduced tuition based on financial need. During the camp sessions, 9 professional teaching artists worked with campers on the exploration and development of original works of theater, music, dance and visual art. Approximately 400 people attended the final performances and presentations associated with these camps.

4b (Code: Prod) (Expenses \$ 68946 including grants of \$ -0-) (Revenue \$ 33879)

Producing Theater: Creative Cauldron produced five theatrical productions in 2011: THE SELFISH GIANT (March 18-April 10, 2011); TINNERS HILL PORTRAITS IN BLACK AND WHITE (June 2-12, 2011); NEVERMORE (October 7-30, 2011); EDDIE ALLAN POE (Nov 4-20, 2011) and CHRISTMAS CABIN OF CARNAWEEN (December 2-18, 2011) for a total of 58 performances with 2,556 patrons attending. 51 professional artists, 21 students and 17 volunteers were involved in these productions. Two of these productions, THE SELFISH GIANT and EDDIE ALLEN POE, were produced under the umbrella of our Learning Theater program that features professional actors alongside community and student performers.

4c (Code: Wrkshps) (Expenses \$ 34850 including grants of \$ -0-) (Revenue \$ 28985)

Creative Cauldron offered 27 individual arts enrichment workshops and 196 private lessons in which 720 children and adults participated. Workshops were held on-site at ArtSpace Falls Church and at three Falls Church area elementary schools. Workshops averaged 16-20 hours in length and needs-based scholarships were offered to children from low-income families. Workshops included KIDSPLAY, an integrated arts program for children in grades K-5, DANCE THEATER, ART OF THE STORYBOOK, HIP HOP DANCE, and ADULT WATERCOLOR. Four workshop demonstrations were offered in conjunction with Creative Cauldron's PASS-PORT TO THE WORLD SERIES, providing opportunities for patrons to learn ethnic dance, or learn about traditional instruments and music from different cultures.

Form 990 Part III 4d, Presenting/Guest Artists: In addition to theatrical productions, Creative Cauldron presented 29 performances by guest music, dance and theater troupes throughout the year. 1,465 patrons attended these events which involved 185 artists and 16 volunteers. These events included PASSPORT TO THE WORLD, A FESTIVAL OF MUSIC, DANCE, ART AND STORY. During the course of this 8-week festival (January 14-March 6, 2011) audiences of all ages were invited to take a cross-cultural journey through performances, workshops, demonstrations and interactive events. Music and dance groups representing diverse musical traditions from Eastern Europe, Asia, Africa and Latin America performed during weekend residencies at ArtSpace Falls Church. Teaching artists from Creative Cauldron collaborated in the series on staged readings of traditional folktales or myths, and guest artists provided educational demonstrations for children participating in Creative Cauldron's summer camps. A FOURTHWALL CABARET SERIES (August 6-Sept. 24) was also presented. 7 Cabaret performances were offered featuring professional musical theater performers who sang selections from Broadway and pop standards. Other guest offerings included a special lecture by George Mason neuroscientist THE SILENCE OF IMAGINATION (January 6, 2011) and a documentary film screening of QUEEN OF THE BEES (May 26, 2011). Our resident artist partner, Falls Church Arts, hosted art exhibits in our gallery, special artists receptions and educational programs. Approximately 35 events were held with an estimated 4,000 in attendance.
