The Association provides equipment, the telephone network, addressing, mapping, phone number database administration, and partial funding for system operations to enable member counties to provide enhanced 911. The Association provides the system for Public Safety Answering Points to answer 911 emergency calls with enhanced data and location specific mapping information for all phone services including landline, wireless, voice over ip.
